ORDER:-

In the letter first read above, the Government of India have conveyed the sanction of the President of India to the release of 640.50 lakh for procurement of New Kitchen Devices and replacement of Kitchen Devices at primary and upper primary stage under National Programme of Mid Day Meal in Schools (MDM scheme) for 2013-2014 at the rate of Rs.5,000/- per school / centre as detailed below:-

2) Accordingly, the Commissioner of Social Welfare has sent the proposal for sanction of funds for replacement of cooking equipment purchase of new kitchen devices in 6979 new schools and replacement of Kitchen Devices for 5831 Noon Meal Centres under National Programme of Mid Day Meal in Schools (MDM Scheme) at the rate of Rs.5000/- per school/per Noon Meal centre at a total cost of Rs.640.50 lakh indicating the name of districts, allotment of funds and number of Nutritious Meal Centres for which cooking equipment /kitchen devices have to be provided/replaced for the financial year 2013-2014 both for the primary and the upper primary states.

3) After careful consideration of the proposal of the Commissioner of Social Welfare and Government accord sanction to the Commissioner of Social Welfare to incur the expenditure to the tune of Rs.640.50 lakh (Rupees six crores forty lakh and fifty thousand only) towards procurement of Kitchen Devices for 6979 new schools and replacement kitchen devices in 5831 School Noon Meal centres in 32 Districts at Rs.5,000/- per school under the National Programme of Mid Day Meals in schools as per the Annexure I and II.

4) The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

" 2236 – Nutrition-02 – Distribution of nutritious food and beverages – 102 Mid Day Meals Schemes in the Twelfth Five Year Plan – III Centrally Sponsored – SA – National Programme of Nutritional Support to Primary Education (Mid Day Meal Scheme) – 24 Materials and Supplies "

5) The expenditure sanctioned in para 3 above has been provided in F.M.A.. 2013-2014, The Commissioner of Social Welfare is authorized to incur the above expenditure.

6) The Commissioner of Social Welfare is requested to implement the programme in the districts with the allocation of funds following the guidelines of NPNSPE, 2006 as stipulated in para 2.3 (vi). The District Collectors concerned, are permitted to purchase cooking equipments / kitchen devices (stove) containers for storage of food grains and other ingredients and utensils for cooking and serving on the basis of the actual requirements of the schools. As far as possible procurement of cooking equipments & kitchen devices shall be done in a decentralized manner preferably at school / block level, so that there is no delay in making available the required devices to the schools as instructed by the Government of India.

7) The Commissioner of Social Welfare and District Collectors shall maintain a separate and proper account of the money received. A register of Assets acquired out of this release shall be maintained as per rules in force. The Commissioner of Social Welfare shall furnish the utilization certificate to Government indicating the number of schools in district wise where kitchen equipments / devices have been provided through the Central Assistance received in this order and as well as quarterly progress reports periodically.

8) The Commissioner of Social Welfare is requested to issue necessary instructions to Personal Assistants (NMP) to District Collectors to implement the scheme, without any deviation and also to

- a) ensure better monitoring and implementation of the scheme ;
 - b) ensure that the kitchen devices / utensils are uniform in type and design, according to the strength ;
