ORDER:-

In the Government Order first read above, orders were issued for providing Lumpsum Grant of ₹50,000 to the Anganwadi Workers and Nutritious Meal Organisers and ₹20,000 to the Anganwadi Helpers, Cooks and Cook Assistants at the time of their retirement with effect from 01.04.2005.

2) The Hon'ble Chief Minister has announced on the floor of Assembly on 19.02.2016 under Rule 110 of Tamil Nadu Legislative Assembly that the existing Lumpsum Grant of ₹50,000 for Anganwadi Workers and Nutritious Meal Workers has been enhanced to ₹60,000 and Lumpsum Grant of ₹20,000 to Mini Anganwadi Workers, Anganwadi Helpers, Nutritious Meal Cooks and Nutritious Meal Cook Assistants has been enhanced to ₹25,000.

3. In the letter third read above, the Director/Mission Director, Integrated Child Development Services Scheme has sent the proposal to the Government regarding necessary budget requirement towards the enhancement of Lumpsum Grant to 660 Anganwadi Workers and Helpers who will be retired during the month of

February 2016 and March 2016. The details of the budget requirement are as follows:-




