ORDER:-

In the Government Order first read above, the Government have issued orders enhancing the Hill Allowance and Winter Allowance to the Government employees working in hill stations.

2. During the meeting held on 06-04-2015 and 08-04-2015 under the Chairmanship of the Hon'ble Chief Minister and a meeting held on 13-04-2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme, Higher Education and School Education with various Nutritious Meal Workers Associations, the Government have interalia deliberated and decided to sanction monthly Hill Allowance and Winter Allowance to Nutritious Meal Programme Workers working at notified Hill areas.

3. In the letter second read above, the Commissioner of Social Welfare has sent proposal stating that representations have been received from various Nutritious Meal Programme Employees Associations demanding sanction of Hill Allowance and Winter Allowance for the Nutritious Meal Programme Workers working in the Nutritious Meal Programme centres located in the Hill areas as already sanctioned to regular Government employees. The Commissioner of Social Welfare has therefore requested the Government to issue necessary orders to sanction monthly Hill Allowance and

Winter allowance to Nutritious Meal Programme Workers working in Hill stations at a total expenditure of ₹1.37 crore.

4. After careful examination, the Government issues the following orders as a Special Case :-

- i. Accord sanction of Hill allowance @ 20% of Basic Pay + Grade pay per month subject to the ceiling to be fixed from time to time for 12 months under Puratchi Thalaivar M.G.R. Nutritious Meal Programme Scheme as a Special Case.
- ii. Accord sanction of Winter allowance @ 5% of Basic Pay per month + Grade pay of Nutritious Meal Programme Workers subject to the ceiling to be fixed from time to time for 4 months applicable to Nutritious Meal Programme Workers who are working in Hill areas 1000 metres to 1499 metres above Mean Sea Level (MSL) under Puratchi Thalaivar M.G.R. Nutritious Meal Programme Scheme as a Special Case.
- iii. The Commissioner of Social Welfare is requested to send necessary proposal for sanction of funds to Government in Finance Department separately after arriving at actuals.
