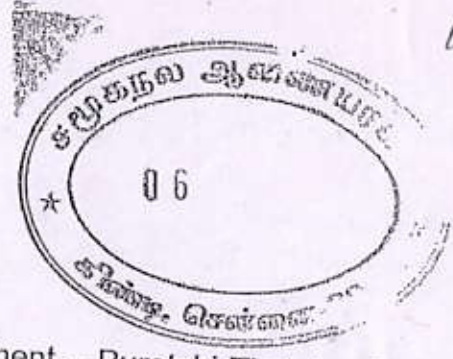

ORDER:

In the Government Order first read above, orders were issued to sanction increments to Nutritious Meal Programme Employees who have completed 10 years of service from the date of their joining by considering the factual position that Nutritious Meal Programme Employees who have completed more than 25 years of service and freshly recruited are receiving same emoluments.

2. During the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and a meeting held on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme, Higher Education and School Education with various Nutritious Meal Workers Association, the Government have interalia deliberated and decided to provide the following:

- i. Sanction of Special Increment for those who could not get promotion even after completing 10/20/30 years of service in a single post under the Puratchi Thalaivar MGR Nutritious Meal Programme Scheme
- ii. Sanction of one increment for every two years as stagnation increment for Nutritious Meal Programme Employees who could not get promotion even after completing 30 years of service in a single post.

3. In the letter 3<sup>rd</sup> read above, the Commissioner of Social Welfare has sent proposal to sanction special increment and stagnation increment to Nutritious Meal Programme Employees who have completed to 10 years/20 years/30 years of service and he has therefore requested the Government to issue necessary orders in this regard.

4. After careful examination, the Government issues the following orders:-
  - i. Sanction of one Increment to Noon Meal Organiser/Cook/Cook Assistant who could not get promotion even after completing 10/20 years of service in a single post as a special case.
  - ii. Sanction of one stagnation increment once in two years as stagnation increment to Noon Meal Organiser/Cook/Cook Assistant for those who could not get promotion even after completing 30 years of service in a single post as a special case.
  - iii. The Commissioner of Social Welfare is requested to send the actual commitment of expenditure towards providing special increment to such category of Noon Meal Organiser/Cook/Cook Assistant to Finance Department for additional allocation separately.


