ORDER:

In the meeting held on 06.04.2015 and 08.04.2015 under the Chairmanship of Hon'ble Chief Minister and on 13.04.2015 by the Hon'ble Ministers for Social Welfare and Nutritious Meal Programme, Higher Education and School Education with Nutritious Meal Workers Associations, Government have interalia deliberated and decided to permit the Nutritious Meal Programme Workers for Voluntary Retirement with benefits as per the rules under medical grounds.

2. In the letter read above, the Commissioner of Social Welfare has sent proposal stating that the Nutritious Meal Programme Workers those who are unable to continue the service due to severe medical grounds and without pending any criminal / disciplinary proceedings may be allowed to retire Voluntarily from service with eligible retirement benefits. Since various Nutritious Meal Programme Workers Association were also insisting on this demand, the Commissioner of Social Welfare has requested the Government to issue necessary orders.

3. After careful examination, the Government permit Special Voluntary Retirement to the willing Nutritious Meal Programme Workers under PTMGR Scheme subject to the following conditions:-

- i) Furnish medical certificate obtained from Medical Board on their inability / illness.
- ii) On attaining the age of 50 years or 20 years of qualifying service, giving 3 months prior notice to the appointing authority.
- iii) Not involved in any civil / criminal cases.
- iv) No, pending contemplated action against the Nutritious Meal Programme Workers for shortcomings in her / his performance.


