ORDER:

In the Government order 1st read above, orders were issued that Special Pension has been fixed to the following categories of Anganwadi and Noon Meal Workers with effect from 15.09.2008 as detailed below:-

Anganwadi Helpers Grade II/ Cook Assistant	Rs.500 p.m.
Anganwadi Helpers Grade I / Cook	Rs.600 p.m.
Noon Meal Organisers, Anganwadi Workers and Mini Anganwadi Workers	Rs.700 p.m.

2. The Hon'ble Chief Minister has announced on the Floor of Assembly on 17.04.2013 under Rule,110 of Tamilnadu Legislative Assembly that, the existing Special Pension for Anganwadi Workers and Nutritious Meal Workers has been enhanced to Rs.1000/-. The necessary additional funds of Rs.26.95 crore will be allocated in due course.

3. In the letter 3rd read above, based on the above announcement, the Principal Secretary / Commissioner, Integrated Child Development Services Scheme has sent

the proposal stating that the Special Pension to all the retired Anganwadi Workers be enhanced to Rs.1000/- per month with effect from 01.05.2013 and she has furnished the details of financial commitment based on the Number of Anganwadi Workers retired upto 31.03.2013 as follows:
